Reports and Parishioner's Question Time

Norfolk County Council (NCC)

County Councillor Roper reported that the council have appealed to central government regarding the Norwich Western Link as they are unable to get planning permission at this stage following the publication of updated guidance on barbastelle bats which was published by Natural England in March this year, days before the planning application was due to be published.

The council are waiting for an announcement from central government identify areas for devolution, ten counties have been identified, these areas will have to decide if they want to form a unitary council.

The planned closure on Buxton Road did not go ahead due to a burst water main.

Surfacing dressing due to be carried out on Park Road will be carried, works will then take place on Crostwick Lane in May/June.

Councillor Roper reported that the speed limit has been reduced on Trafford Way to 20mph not sure who made the application.

Written apologies were received from Councillor S Vincent and Councillor K Harkin-Perry.

2. DECLARATIONS OF INTEREST None.

3. HIGHWAY MATTERS

Councillor Daly asked when the Village Gateway sign would be installed on Church Lane, Councillor Roper had said he hoped it would be soon but has not been given an actual date.

The clerk advised that she has emailed the engineer for further information on the cost of the parish council bid but had not heard anything. Councillor Roper advised to send in the bid form and CC in himself and the Highway Engineer.

4. CO-OPTION OF PARISH COUNCILLORS

No applications were received.

5. MINUTES OF PREVIOUS MEETING

The Minutes of the Annual Council Meeting held on the 5^{th of} November 2024 were agreed and signed off by the Chairman as a true record.

6. TO RECEIVE MONTHLY ACTION PLAN UPDATE.

The clerk provided a printout of the monthly action sheet. Councillor Field advised he needs to place the new grit bin on William Peck Close. Councillor Rowe offered to place the other new grit bin on Arthurton Road next to the amenity land.

The clerk advised that purchasing name cards for councillors was too expensive. It was suggested to purchase some lanyards instead and print of councillor details to wear when carrying out parish visits.

7. FINANCE

- 7.1 Balances were noted and the following payments were authorised in accordance with the budget as per the tabled scheduled 3rd December were agreed.
- 7.2 The Bank Reconciliation as of the 27th of November 2024 was agreed.
- 7.3 The clerk circulated a hard copy of the draft budget for 2025/26. It was agreed to remove section 106 and CIL income from the budget sheet and show separately as reserves. The figures shown on expenditure excluded VAT therefore the VAT income section was removed.

The budget for Orchard Road Play area was reduced to include repairs and maintenance only, CIL money has been set aside for bigger improvements. The repairs and maintenance budget were also reduced for the Village Hall Play Area as it has been newly installed.

It was also agreed to reduce the grants budget to £500.

Because the council have not increased the precept for the last 7 years it was agreed to set the amount at £111,000.15 to cover rising costs/inflation. Proposed by councillor Knight and seconded by councillor field.

7.4 A resident has complained to the council about a dog bin on St Peter's Way that is too small for the amount dog waste that is put into it on a daily basis. The current lid causes bags to get stuck and creates an unpleasant smell. The council agreed to replace the bin with a suitable lid and monitor the collection frequency.

7.5 It was agreed to leave the Jubilee bench in storage until Maisie's Meadow had been landscaped.

9.1 Several posts have been reported broken on the Greg's Meadow Picnic enclosure fence, although some have now been repaired it was suggested due to the age and quality of the fence that it would be more cost effective to replace the fence with a more robust material. Clerk to look at quotes for a new fence.

9.2 The clerk presented the council with details of several quotes for Maisie's Meadow Landscape project due to the variation in price on installing a path the council asked the clerk to look into the difference in cost and materials and report back to the next meeting.

9.3 The clerk was contacted by a resident who knew the family that had the memorial bench installed on Crostwick Lane. Because the bench is now severely damaged and dangerous the council will need to remove this. Clerk to update resident and pass on information to family.

Councillor Beiley suggested the council produce a digital newsletter every quarter which he is happy to lead on, council agreed this was an innovative idea.
