Councillor Holland advised that she contact Councillor Roper for an update on the 30mph limit roundels due to be painted on the NDR bridge on Buxton Road.

The council agreed to schedule a highway and amenity walkabout on Tuesday 6th June prior to the next meeting.

12.AMENITY MATTERS

The clerk advised that she is still waiting for a response from Hopkins Homes regarding the transfer of amenity land to the Parish Council. It has now been 8 years since it was due to be transferred. The Parish Council received a copy of the TP1 transfer of land to be registered document in December 2022 but has not heard anything since. The clerk has contacted Broadland District Council Planning to chase this up.

Councillor Cullington advised that Spixworth Youth Football Club are in desperate need of another football pitch as the club expands with more players. It was discussed that the land is big enough for a small football pitch and dog walking area.

Councillor Knight advised that the council need to make a decision on what the amenity land could provide for the people of Spixworth. Clerk to add as an item for discussion for the September 2023 agenda.

13.ALLOTMENTS

13.1 The council agreed the terms of the Deed of Variation and TP1 transfer deed. It was signed by the chairman and vice chairman.
