Norfolk County Council: A scrutiny committee was held to discuss cost of the NDR, the land still needs signing off to avoid any further costs. Councillor V Barrell if the repairs to the NDR were included into the cost of building the NDR. Councillor Roper will look at budget regarding maintenance costs.

Councillor P Rowe asked if more chevron signs will be placed on the roundabouts, Councillor D Roper confirmed that there will be.

5. MINUTES OF PREVIOUS MEETING

The Minutes of the previous meeting held on the 5th November 2019 were agreed. and signed off by the Chairman as a true record.

7. FINANCE

- 7.1 Balances were noted. The following cheques and payments were authorised for payment in accordance with the budget as per tabled schedule 4th December 2019. , proposed by Councillor P Rowe, seconded by Councillor V Barrell.
- 7.2 Bank Reconciliation as of 28th November 2019 was noted and signed by the Chairman. Payments were approved by full council.
- 7.3 The council agreed to the budget and precept figures for 2020/21
- 7.4 The clerk obtained a quote to repair the broken rope climbing frame situated on the village hall playing field. Kompan quoted a price of £482.18 for a new rope and sphere ball and net connector. The council felt this was expensive and whether or not for now the entire rope and sphere is removed. Councillor V Barrell confirmed he will take a look and make a decision whether or not to remove it.
- 7.5 The clerk advised the council that HMRC had charged another penalty fee for late filing of submissions for quarter ending 5th October 2019. The clerk had already appealed against a penalty for quarter ending 5th July but HMRC refused and ordered the council to pay. HMRC expect salary payment information to be sent to them on or before the date they are paid. The clerk was not aware of this and has always sent submissions after the council meetings. Councillor K Vincent suggested that the council write a letter on top on the clerk's letter to appeal against the second penalty.
- 7.6 The clerk presented the council with a copy of the latest donation policy information and application form. At the previous council meeting, Councillor S Holland asked for this to be reinstated but Councillor S Vincent feels it shouldn't be brought back as it caused several problems a few years back, the administration of the donation requests took up a lot of time. Councillor S Vincent agreed to support one off requests from organisations as long as it supports things within the village of Spixworth. The council agreed with this.
